- These stock appreciation rights represent the right to receive a cash payment equal to the excess, if any, of (i) the fair market value of each underlying share of the Company's common stock, determined on the date of exercise minus (ii) the exercise price; provided, that in no event may the cash payment for each stock appreciation right exceed \$1.03, which is the maximum price per share of \$2.54, minus the base amount of \$1.51, subject to adjustment in accordance with the terms of the award agreement.
